An initial payment of \$100.00 made payable to the Catholic Diocese of Arlington must accompany this Fact Sheet. The total fee for this process is \$475.00. Upon receipt of this information, a more detailed questionnaire will be sent to the Petitioner by the Tribunal along with a request for the appropriate civil/ecclesiastical documents (e.g., baptismal certificates for ALL Catholic parties, marriage license/applications for ALL unions, final divorce decrees for ALL unions). Note that good quality photocopies of documents are acceptable.
