## SUPPLEMENTAL QUESTIONS FOR CONVALIDATION

In this section, the term Catholic Church wedding refers to the convalidation in the Catholic Church. The term civil wedding refers to any civil or non-Catholic religious celebration of a wedding that came before the Catholic convalidation. It is important to distinguish between the non-Catholic ceremony and the convalidation (wedding in the Catholic Church).

Please be sure to separate the facts concerning the civil wedding from those concerning the Catholic wedding in answering the following questions.
